WHO ENJOYS LONG-FORM TRUE CRIME PODCASTS?

THE ENDURING APPEAL OF LONG-FORM TRUE CRIME

WHAT DEFINES LONG-FORM TRUE CRIME PODCASTS?

LONG-FORM TRUE CRIME PODCASTS ARE CHARACTERIZED BY THEIR EXTENDED EPISODE LENGTHS, OFTEN SPANNING 45 MINUTES TO OVER AN HOUR, AND FREQUENTLY DEVELOPING A SINGLE CASE OR A SERIES OF INTERCONNECTED CASES ACROSS AN ENTIRE SEASON. THIS EXTENDED DURATION ALLOWS FOR A DEPTH OF INVESTIGATION AND NARRATIVE DEVELOPMENT THAT SHORTER FORMATS SIMPLY CANNOT ACCOMMODATE. UNLIKE EPISODIC PODCASTS THAT MIGHT COVER MULTIPLE BRIEF STORIES IN ONE SITTING, LONG-FORM PRESENTATIONS ARE DESIGNED TO BUILD A COMPREHENSIVE PICTURE, INCORPORATING EXTENSIVE INTERVIEWS, ARCHIVAL AUDIO, AND DETAILED ANALYSIS. THEY PRIORITIZE UNFOLDING THE NARRATIVE AT A DELIBERATE PACE, ALLOWING LISTENERS TO BECOME FULLY IMMersed IN THE DETAILS OF THE INVESTIGATION, THE LIVES OF THOSE INVOLVED, AND THE LEGAL OR PSYCHOLOGICAL COMPLEXITIES AT PLAY.

THE DEFINING FEATURE OF THE BEST TRUE CRIME PODCASTS LONG FORM IS THEIR COMMITMENT TO THOROUGHNESS. THIS MEANS NOT JUST PRESENTING THE FACTS OF A CRIME BUT ALSO EXPLORING THE "WHY" AND THE "HOW" WITH A LEVEL OF DETAIL THAT ENGAGES CRITICAL THINKING. THEY OFTEN INVOLVE YEARS OF RESEARCH, MULTIPLE INTERVIEWS WITH KEY FIGURES, AND A NARRATIVE STRUCTURE THAT BUILDS SUSPENSE AND REVEALS INFORMATION GRADUALLY. THE GOAL IS TO PROVIDE A COMPLETE, NUANCED UNDERSTANDING OF THE EVENTS, OFTEN CHALLENGING INITIAL ASSUMPTIONS AND HIGHLIGHTING THE AMBIGUITIES INHERENT IN MANY CRIMINAL INVESTIGATIONS. THIS DEPTH OF REPORTING DISTINGUISHES THEM FROM MORE SENSATIONALIZED OR SUPERFICIAL TRUE CRIME CONTENT.

THE ART OF LONG-FORM TRUE CRIME STORYTELLING

CRAFTING A COMPELLING LONG-FORM TRUE CRIME PODCAST IS A DELICATE ART THAT REQUIRES A UNIQUE BLEND OF INVESTIGATIVE JOURNALISM, STORYTELLING PROWESS, AND TECHNICAL SKILL. THE NARRATIVE ARC IS CRUCIAL; IT'S NOT SIMPLY A RECOUNTING OF EVENTS BUT A STRUCTURED UNFOLDING DESIGNED TO KEEP THE LISTENER ENGAGED OVER MULTIPLE EPISODES. THIS OFTEN INVOLVES CLIFFHANGERS, CHARACTER DEVELOPMENT OF BOTH THE ACCUSED AND THE INVESTIGATORS, AND THE STRATEGIC RELEASE OF NEW INFORMATION THAT ALTERS THE LISTENER'S PERCEPTION OF THE CASE.

SOUND DESIGN PLAYS AN EQUALLY VITAL ROLE IN LONG-FORM TRUE CRIME. BEYOND CLEAR NARRATION, EFFECTIVE USE OF AMBIENT SOUNDS, ARCHIVAL AUDIO CLIPS, AND DRAMATIC MUSIC CAN TRANSPORT LISTENERS DIRECTLY INTO THE SCENE, ENHANCING THE EMOTIONAL IMPACT AND REALISM OF THE STORYTELLING. THE PACING OF THE NARRATIVE, ACHIEVED THROUGH EDITING AND THE CAREFUL SELECTION OF INTERVIEW SEGMENTS, IS PARAMOUNT IN MAINTAINING LISTENER ATTENTION ACROSS EXTENDED PERIODS. A WELL-EXECUTED LONG-FORM PODCAST FEELS LESS LIKE A REPORT AND MORE LIKE AN ENGROSSING AUDITORY DOCUMENTARY, INVITING DEEP CONTEMPLATION AND EMOTIONAL CONNECTION.

TOP LONG-FORM TRUE CRIME PODCASTS TO EXPLORE

THE LANDSCAPE OF LONG-FORM TRUE CRIME PODCASTS IS RICH AND VARIED, WITH SEVERAL SERIES SETTING THE STANDARD FOR IN-DEPTH JOURNALISTIC INVESTIGATION AND CAPTIVATING STORYTELLING. THESE SHOWS HAVE EARNED ACCLAIM FOR THEIR METICULOUS RESEARCH, ETHICAL REPORTING, AND ABILITY TO SHED NEW LIGHT ON OFTEN-FORGOTTEN OR MISUNDERSTOOD CASES.

SERIAL

ARGUABLY THE PODCAST THAT BROUGHT LONG-FORM TRUE CRIME TO MAINSTREAM PROMINENCE, SERIAL'S FIRST SEASON METICULOUSLY RE-EXAMINED THE 1999 CONVICTION OF ADNAN SYED FOR THE MURDER OF HIS EX-GIRLFRIEND, HAE MIN LEE. HOST SARAH KOENIG'S IN-DEPTH INVESTIGATION, FEATURING EXTENSIVE INTERVIEWS AND ANALYSIS OF EVIDENCE, RAISED SIGNIFICANT QUESTIONS ABOUT THE ORIGINAL TRIAL. THE SUBSEQUENT SEASONS HAVE EXPLORED DIFFERENT CASES, MAINTAINING THE SHOW'S COMMITMENT TO DEEP DIVES INTO COMPLEX LEGAL AND HUMAN DRAMAS.

S-TOWN

WHILE NOT STRICTLY A "CRIME" PODCAST, S-TOWN, FROM THE CREATORS OF SERIAL AND THIS AMERICAN LIFE, DELVES INTO THE LIFE OF JOHN B. MCLEMORE, A HOROLOGIST IN WOODSTOCK, ALABAMA. THE PODCAST UNEXPECTEDLY TRANSFORMS INTO A TRUE CRIME INVESTIGATION AS IT UNCOVERS SECRETS, FEUDS, AND A SUSPICIOUS DEATH. ITS LONG-FORM NARRATIVE STYLE IS EXCEPTIONAL IN ITS ABILITY TO EXPLORE THE NUANCES OF A SMALL-TOWN COMMUNITY AND THE COMPLEX PSYCHOLOGY OF ITS INHABITANTS, MAKING IT A MUST-LISTEN FOR FANS OF NARRATIVE-DRIVEN AUDIO.

DIRTY JOHN

THIS PODCAST, CREATED BY CHRISTOPHER GOFFARD FOR THE LOS ANGELES TIMES, RECOUNTS THE CHILLING STORY OF JOHN MEEHAN, A CHARISMATIC BUT DANGEROUS CON ARTIST WHO MANIPULATES DEBRA NEWELL. THE LONG-FORM APPROACH ALLOWS LISTENERS TO WITNESS THE SLOW, INSIDIOUS UNFOLDING OF MEEHAN'S DECEPTION AND ITS DEVASTATING IMPACT ON NEWELL AND HER FAMILY, HIGHLIGHTING THE PSYCHOLOGICAL MANIPULATION AT THE HEART OF THE CRIME.

BEAR BROOK

BEAR BROOK, FROM NEW HAMPSHIRE PUBLIC RADIO, TACKLES A COLD CASE INVOLVING FOUR UNIDENTIFIED BODIES FOUND IN BARRELS IN 1985. THE PODCAST FOLLOWS THE FORENSIC GENEALOGY INVESTIGATION THAT EVENTUALLY IDENTIFIED THE

VICTIMS AND THE KILLER, SHOWCASING HOW MODERN SCIENTIFIC TECHNIQUES CAN UNLOCK DECADES-OLD MYSTERIES. ITS MULTI-PART STRUCTURE EFFECTIVELY BUILDS SUSPENSE AND EXPLAINS THE COMPLEX SCIENTIFIC PROCESSES INVOLVED.

IN THE DARK

PRODUCED BY APM REPORTS, IN THE DARK HAS A DUAL FOCUS: INVESTIGATING THE 2002 ABDUCTION OF JACOB WETTERLING IN ITS FIRST SEASON AND EXAMINING THE SYSTEMIC FAILURES IN THE CASE OF CURTIS FLOWERS, A MAN ACCUSED OF MURDERING FOUR PEOPLE, IN ITS SECOND SEASON. THE LONG-FORM INVESTIGATIVE JOURNALISM IS EXEMPLARY, REVEALING DEEP-SEATED ISSUES WITHIN LAW ENFORCEMENT AND THE JUSTICE SYSTEM, MAKING IT ONE OF THE MOST IMPACTFUL TRUE CRIME PODCASTS AVAILABLE.

COLD

THIS PODCAST, HOSTED BY DAVE CAWLEY, IS A DEEP DIVE INTO THE 1998 DISAPPEARANCE OF SUSAN POWELL AND THE SUBSEQUENT MURDER INVESTIGATION INVOLVING HER HUSBAND, JOSH POWELL. "COLD" METICULOUSLY RECONSTRUCTS THE TIMELINE OF EVENTS, UNCOVERS NEW EVIDENCE, AND EXPLORES THE FAMILY DYNAMICS AND LEGAL BATTLES THAT SPANNED OVER TWO DECADES. ITS COMMITMENT TO ONGOING INVESTIGATION AND ITS DETAILED NARRATIVE MAKE IT A COMPELLING LISTEN.

UNCOVER

CBC'S UNCOVER SERIES OFFERS A RANGE OF INVESTIGATIVE DEEP DIVES INTO SIGNIFICANT CANADIAN TRUE CRIME STORIES. WHILE EACH SEASON FOCUSES ON A DIFFERENT CASE, THE LONG-FORM APPROACH ALLOWS FOR THOROUGH EXPLORATION. NOTABLE SEASONS INCLUDE THE INVESTIGATION INTO THE 1978 DISAPPEARANCE OF BARBARA AND DENNIS TYNECKI AND THE UNCOVERING OF SYSTEMIC ISSUES IN THE INVESTIGATION OF HISTORICAL SEXUAL ABUSE IN THE RESIDENTIAL SCHOOL SYSTEM. THE SERIES CONSISTENTLY DEMONSTRATES RIGOROUS JOURNALISTIC STANDARDS.

KEY ELEMENTS OF EXCEPTIONAL LONG-FORM TRUE CRIME

WHAT ELEVATES A TRUE CRIME PODCAST FROM MERELY INFORMATIVE TO TRULY EXCEPTIONAL IS A COMBINATION OF METICULOUS CRAFT AND ETHICAL CONSIDERATION. THE BEST LONG-FORM PODCASTS EXCEL IN SEVERAL KEY AREAS, ENSURING A PROFOUND AND IMPACTFUL LISTENING EXPERIENCE FOR THEIR AUDIENCE.

METICULOUS RESEARCH AND REPORTING

AT THE CORE OF ANY OUTSTANDING LONG-FORM TRUE CRIME PODCAST IS AN UNWAVERING COMMITMENT TO THOROUGH RESEARCH. THIS INVOLVES DELVING INTO COURT DOCUMENTS, POLICE REPORTS, INTERVIEWS WITH WITNESSES, EXPERTS, AND THOSE DIRECTLY INVOLVED, AS WELL AS EXAMINING HISTORICAL CONTEXT. THE BEST PODCASTS DON'T SHY AWAY FROM THE NITTY-GRITTY DETAILS, PIECING TOGETHER TIMELINES, MOTIVATIONS, AND THE INTRICACIES OF INVESTIGATIONS WITH PAINSTAKING ACCURACY. THIS DEPTH OF REPORTING BUILDS CREDIBILITY AND ALLOWS FOR A COMPREHENSIVE UNDERSTANDING OF THE CASE, OFTEN UNCOVERING NEW PERSPECTIVES OR CHALLENGING COMMONLY HELD BELIEFS.

COMPELLING NARRATION AND SOUND DESIGN

EVEN THE MOST THOROUGHLY RESEARCHED STORY NEEDS TO BE TOLD IN A WAY THAT CAPTIVATES THE LISTENER. LONG-FORM PODCASTS RELY ON SKILLED NARRATORS WHO CAN CONVEY COMPLEX INFORMATION CLEARLY AND ENGAGINGLY. BEYOND NARRATION, THE STRATEGIC USE OF SOUND DESIGN IS CRUCIAL. THIS INCLUDES INCORPORATING ARCHIVAL AUDIO, AMBIENT SOUNDS TO RECREATE ENVIRONMENTS, AND A WELL-CHOSEN MUSICAL SCORE TO UNDERScore EMOTIONAL BEATS AND BUILD SUSPENSE WITHOUT BEING MANIPULATIVE. THE INTERPLAY BETWEEN NARRATION AND SOUND CREATES AN IMMERSIVE EXPERIENCE THAT DRAWS THE LISTENER DEEP INTO THE NARRATIVE.

ETHICAL CONSIDERATIONS AND VICTIM-CENTRIC APPROACH

A TRULY EXCEPTIONAL LONG-FORM TRUE CRIME PODCAST APPROACHES ITS SUBJECT MATTER WITH SENSITIVITY AND RESPECT, PARTICULARLY TOWARDS VICTIMS AND THEIR FAMILIES. THIS MEANS PRIORITIZING THEIR PERSPECTIVES, AVOIDING SENSATIONALISM, AND REFRAINING FROM RE-TRAUMATIZING THOSE AFFECTED BY THE EVENTS. THE BEST PODCASTS OFTEN ENGAGE IN ONGOING DIALOGUE ABOUT THE ETHICAL IMPLICATIONS OF THEIR WORK, STRIVING TO PROVIDE CONTEXT AND UNDERSTANDING RATHER THAN SIMPLY RECOUNTING SENSATIONAL DETAILS. THIS RESPONSIBLE APPROACH FOSTERS A MORE MEANINGFUL AND IMPACTFUL LISTENING EXPERIENCE THAT HONORS THE GRAVITY OF THE STORIES BEING TOLD.

EXPLORATION OF SOCIETAL THEMES

BEYOND THE INDIVIDUAL CRIME, THE MOST PROFOUND LONG-FORM TRUE CRIME PODCASTS EXPLORE THE BROADER SOCIETAL ISSUES THAT THE CASE ILLUMINATES. THIS MIGHT INCLUDE EXAMINING SYSTEMIC FAILURES IN THE JUSTICE SYSTEM, BIASES WITHIN LAW ENFORCEMENT, PSYCHOLOGICAL FACTORS, OR THE IMPACT OF MEDIA ON PUBLIC PERCEPTION. BY CONTEXTUALIZING INDIVIDUAL TRAGEDIES WITHIN LARGER SOCIAL FRAMEWORKS, THESE PODCASTS OFFER NOT JUST A RECOUNTING OF EVENTS BUT ALSO A CRITICAL ANALYSIS OF THE WORLD WE LIVE IN. THIS ADDS SIGNIFICANT INTELLECTUAL AND EMOTIONAL WEIGHT TO THE NARRATIVE, ENCOURAGING LISTENERS TO THINK CRITICALLY ABOUT JUSTICE, HUMAN BEHAVIOR, AND SOCIETAL STRUCTURES.

WHO ENJOYS LONG-FORM TRUE CRIME PODCASTS?

THE AUDIENCE FOR LONG-FORM TRUE CRIME PODCASTS IS DIVERSE, UNITED BY A CURIOSITY ABOUT HUMAN NATURE, JUSTICE, AND THE INTRICACIES OF CRIMINAL INVESTIGATIONS. THESE ARE INDIVIDUALS WHO APPRECIATE A DEEP DIVE, SEEKING MORE THAN JUST SURFACE-LEVEL ENTERTAINMENT. THEY ARE OFTEN LISTENERS WHO ENJOY INVESTIGATIVE JOURNALISM, DOCUMENTARIES, AND HISTORICAL ACCOUNTS, APPRECIATING THE EXTENSIVE RESEARCH AND NARRATIVE DEVELOPMENT THAT LONG-FORM PODCASTS OFFER.

MANY LISTENERS ARE DRAWN TO THE INTELLECTUAL CHALLENGE PRESENTED BY THESE COMPLEX CASES. THEY ENJOY DISSECTING EVIDENCE, EXPLORING DIFFERENT THEORIES, AND ENGAGING WITH THE ETHICAL AND PSYCHOLOGICAL DIMENSIONS OF CRIME. THE LONG-FORM FORMAT ALLOWS FOR THIS DEEPER ENGAGEMENT, FOSTERING A SENSE OF PARTICIPATION AS LISTENERS PIECE TOGETHER THE NARRATIVE ALONGSIDE THE HOST. FURTHERMORE, AN APPRECIATION FOR HIGH-QUALITY STORYTELLING, EXPERT NARRATION, AND SOPHISTICATED SOUND DESIGN IS COMMON AMONG FANS OF THE GENRE. THEY SEEK AN AUDIO EXPERIENCE THAT IS BOTH INFORMATIVE AND EMOTIONALLY RESONANT, OFFERING A COMPELLING AND THOUGHT-PROVOKING JOURNEY INTO THE DARKER ASPECTS OF HUMAN EXPERIENCE.

THE ENDURING APPEAL OF LONG-FORM TRUE CRIME

THE ENDURING APPEAL OF THE BEST TRUE CRIME PODCASTS LONG FORM LIES IN THEIR ABILITY TO SATISFY A FUNDAMENTAL HUMAN CURIOSITY ABOUT THE UNEXPLAINED, THE SHOCKING, AND THE PROFOUND QUESTIONS SURROUNDING JUSTICE AND MORALITY. THESE PODCASTS OFFER A UNIQUE WINDOW INTO THE COMPLEXITIES OF THE HUMAN PSYCHE AND THE SOCIETAL STRUCTURES THAT GOVERN OUR LIVES. BY METICULOUSLY DISSECTING CASES, THEY PROVIDE A SENSE OF ORDER AND UNDERSTANDING IN THE FACE OF CHAOS, ALLOWING LISTENERS TO GRAPPLE WITH DIFFICULT TRUTHS IN A CONTROLLED AND IMMERSIVE ENVIRONMENT. THE LONG-FORM NARRATIVE STRUCTURE ITSELF PLAYS A CRUCIAL ROLE, ENABLING A PROFOUND CONNECTION WITH THE STORIES AND THE PEOPLE INVOLVED, FOSTERING EMPATHY AND CRITICAL THINKING.

ULTIMATELY, THESE PODCASTS SERVE AS COMPELLING AUDITORY CASE STUDIES, REMINDING US OF THE IMPORTANCE OF VIGILANT INQUIRY, THE FALLIBILITY OF SYSTEMS, AND THE RESILIENCE OF THE HUMAN SPIRIT. THE PURSUIT OF TRUTH, THE QUEST FOR JUSTICE, AND THE EXAMINATION OF OUR COLLECTIVE UNDERSTANDING OF RIGHT AND WRONG ARE TIMELESS THEMES THAT CONTINUE TO RESONATE, ENSURING THE SUSTAINED POPULARITY OF LONG-FORM TRUE CRIME STORYTELLING. THEY ARE NOT JUST ABOUT RECOUNTING CRIMES; THEY ARE ABOUT UNDERSTANDING THE HUMAN CONDITION IN ITS MOST EXTREME FORMS.

Q: WHAT MAKES A TRUE CRIME PODCAST "LONG FORM"?

A: LONG-FORM TRUE CRIME PODCASTS ARE DEFINED BY THEIR EXTENDED EPISODE LENGTHS, TYPICALLY 45 MINUTES TO OVER AN HOUR, AND OFTEN DEDICATING AN ENTIRE SEASON TO A SINGLE CASE OR A CONNECTED SERIES OF EVENTS. THIS ALLOWS FOR IN-DEPTH INVESTIGATION, DETAILED NARRATIVE DEVELOPMENT, AND THOROUGH EXPLORATION OF EVIDENCE, INTERVIEWS, AND CONTEXT, DISTINGUISHING THEM FROM SHORTER, MORE EPISODIC FORMATS.

Q: ARE LONG-FORM TRUE CRIME PODCASTS ALWAYS SERIOUS?

A: WHILE THE SUBJECT MATTER IS INHERENTLY SERIOUS, THE TONE OF LONG-FORM TRUE CRIME PODCASTS CAN VARY. SOME PRIORITIZE A STRAIGHTFORWARD, JOURNALISTIC APPROACH, WHILE OTHERS MAY INCORPORATE MORE DRAMATIC NARRATION, EMOTIONAL STORYTELLING, OR EVEN MOMENTS OF DARK HUMOR IF APPROPRIATE TO THE NARRATIVE. HOWEVER, THE OVERARCHING GOAL IS USUALLY TO PROVIDE A COMPREHENSIVE AND RESPECTFUL EXAMINATION OF THE CASE.

Q: HOW DO LONG-FORM PODCASTS DIFFER FROM TRUE CRIME DOCUMENTARIES?

A: WHILE BOTH MEDIUMS AIM FOR IN-DEPTH EXPLORATION, LONG-FORM PODCASTS RELY SOLELY ON AUDIO TO TELL THEIR STORIES. THIS MEANS THEY MUST EXCEL IN NARRATION, SOUND DESIGN, AND THE PACING OF INFORMATION DELIVERY TO CREATE AN IMMERSIVE EXPERIENCE. DOCUMENTARIES, ON THE OTHER HAND, CAN UTILIZE VISUAL ELEMENTS LIKE ARCHIVAL FOOTAGE, REENACTMENTS, AND INTERVIEWS TO COMPLEMENT THEIR NARRATIVES.

Q: WHAT KIND OF RESEARCH GOES INTO THE BEST LONG-FORM TRUE CRIME PODCASTS?

A: THE BEST LONG-FORM TRUE CRIME PODCASTS INVOLVE EXTENSIVE RESEARCH, INCLUDING REVIEWING COURT DOCUMENTS, POLICE FILES, NEWS ARCHIVES, AND CONDUCTING MULTIPLE INTERVIEWS WITH INVESTIGATORS, LEGAL PROFESSIONALS, WITNESSES, AND SOMETIMES EVEN INDIVIDUALS INVOLVED IN THE CASE. Q: ARE THERE ETHICAL CONSIDERATIONS FOR CREATORS OF LONG-FORM TRUE CRIME PODCASTS?

A: ABSOLUTELY. ETHICAL CONSIDERATIONS ARE PARAMOUNT. CREATORS MUST STRIVE FOR ACCURACY, AVOID SENSATIONALISM, AND BE SENSITIVE TO VICTIMS AND THEIR FAMILIES. THIS INVOLVES RESPECTFUL STORYTELLING, CAREFUL HANDLING OF SENSITIVE DETAILS, AND A COMMITMENT TO NOT RE-TRAUMATIZE THOSE AFFECTED. MANY PODCASTS ENGAGE IN DISCUSSIONS ABOUT THE ETHICS OF THEIR OWN WORK.

Q: WHAT ARE THE BENEFITS OF LISTENING TO LONG-FORM TRUE CRIME PODCASTS OVER SHORTER ONES?

A: THE PRIMARY BENEFIT IS THE DEPTH OF UNDERSTANDING. LONG-FORM PODCASTS ALLOW FOR A MORE NUANCED EXPLORATION OF MOTIVES, EVIDENCE, LEGAL PROCEEDINGS, AND SOCIETAL CONTEXT. THEY ENABLE LISTENERS TO BECOME MORE INVESTED IN THE CASE, ENGAGE IN CRITICAL THINKING, AND GAIN A MORE COMPLETE AND OFTEN SURPRISING PERSPECTIVE ON COMPLEX CRIMINAL EVENTS.

Q: HOW DO SOUND DESIGN AND NARRATION CONTRIBUTE TO THE EFFECTIVENESS OF LONG-FORM TRUE CRIME PODCASTS?

A: SOUND DESIGN AND NARRATION ARE CRITICAL. COMPELLING NARRATION GUIDES THE LISTENER THROUGH THE INTRICATE DETAILS OF THE CASE, WHILE EFFECTIVE SOUND DESIGN, INCLUDING AMBIENT SOUNDS, MUSIC, AND ARCHIVAL AUDIO, CREATES ATMOSPHERE, ENHANCES EMOTIONAL IMPACT, AND MAKES THE STORYTELLING IMMERSIVE AND MEMORABLE. TOGETHER, THEY TRANSFORM A FACTUAL ACCOUNT INTO A CAPTIVATING AUDITORY EXPERIENCE.

Q: CAN LONG-FORM TRUE CRIME PODCASTS HELP SOLVE COLD CASES?

A: YES, IN SOME INSTANCES. BY BRINGING PUBLIC ATTENTION TO UNSOLVED OR MISHANDLED CASES, LONG-FORM PODCASTS CAN PROMPT NEW LEADS, ENCOURAGE WITNESSES TO COME FORWARD, AND SOMETIMES EVEN SPUR LAW ENFORCEMENT TO RE-EXAMINE EVIDENCE. THE DETAILED INVESTIGATION AND PUBLIC DISSEMINATION OF INFORMATION CAN SOMETIMES BE A CATALYST FOR RENEWED PROGRESS.
