THIS DATA IS INVALUABLE FOR SPOTTING SEASONAL FLUCTUATIONS AND IDENTIFYING PEAK USAGE PERIODS. FOR EXAMPLE, YOU MIGHT NOTICE HIGHER ELECTRICITY BILLS DURING THE SUMMER MONTHS DUE TO INCREASED AIR CONDITIONING USE OR HIGHER NATURAL GAS BILLS IN THE WINTER FOR HEATING. UNDERSTANDING THESE TRENDS IS KEY TO IMPLEMENTING TARGETED STRATEGIES FOR SAVING MONEY ON PGE.

# ENERGY EFFICIENCY UPGRADES FOR SAVINGS

Investing in energy-efficient upgrades is one of the most impactful ways to achieve long-term savings on your PGE bills. These improvements not only reduce your energy consumption but can also increase your home's value and comfort. Consider a range of options, from small, inexpensive changes to larger, more significant renovations.

#### HOME INSULATION AND SEALING

PROPER INSULATION IN ATTICS, WALLS, AND CRAWL SPACES IS PARAMOUNT FOR MAINTAINING A COMFORTABLE INDOOR TEMPERATURE AND PREVENTING ENERGY LOSS. HEAT NATURALLY FLOWS FROM WARMER AREAS TO COOLER AREAS, MEANING

THAT IN THE WINTER, YOUR HEATED AIR ESCAPES, AND IN THE SUMMER, UNWANTED HEAT ENTERS YOUR HOME. AIR SEALING, WHICH INVOLVES IDENTIFYING AND PLUGGING LEAKS AROUND WINDOWS, DOORS, ELECTRICAL OUTLETS, AND OTHER PENETRATIONS IN YOUR HOME'S ENVELOPE, IS EQUALLY IMPORTANT. THESE SEEMINGLY SMALL LEAKS CAN COLLECTIVELY ACCOUNT FOR A SIGNIFICANT AMOUNT OF WASTED ENERGY.

SIMILARLY, SWITCHING FROM INCANDESCENT LIGHT BULBS TO LED (LIGHT EMITTING DIODE) BULBS IS A SIMPLE YET HIGHLY EFFECTIVE WAY TO REDUCE ELECTRICITY CONSUMPTION FOR LIGHTING. LEDS USE SIGNIFICANTLY LESS ENERGY AND LAST MUCH LONGER THAN TRADITIONAL BULBS.

#### HVAC System Efficiency

YOUR HEATING, VENTILATION, AND AIR CONDITIONING (HVAC) SYSTEM IS OFTEN THE LARGEST ENERGY CONSUMER IN YOUR HOME. REGULARLY MAINTAINING YOUR HVAC SYSTEM, INCLUDING CLEANING OR REPLACING AIR FILTERS, CAN IMPROVE ITS EFFICIENCY. CONSIDER UPGRADING TO A HIGH-EFFICIENCY FURNACE, AIR CONDITIONER, OR HEAT PUMP. PROGRAMMABLE OR SMART THERMOSTATS ALSO PLAY A VITAL ROLE IN MANAGING HVAC USAGE, ALLOWING YOU TO SET SPECIFIC TEMPERATURE SCHEDULES FOR DIFFERENT TIMES OF THE DAY.

## BEHAVIORAL CHANGES TO REDUCE CONSUMPTION

DURING COLDER MONTHS, SET YOUR THERMOSTAT A FEW DEGREES LOWER WHEN YOU ARE ASLEEP OR AWAY FROM HOME. IN WARMER MONTHS, RAISE THE TEMPERATURE WHEN YOU ARE NOT PRESENT. SMART THERMOSTATS CAN LEARN YOUR PATTERNS AND AUTOMATICALLY ADJUST, FURTHER OPTIMIZING SAVINGS.

#### MINDFUL APPLIANCE USE

THERE ARE NUMEROUS WAYS TO USE YOUR APPLIANCES MORE EFFICIENTLY. FOR INSTANCE, RUNNING YOUR DISHWASHER AND WASHING MACHINE ONLY WHEN THEY ARE FULL CAN SAVE WATER AND ENERGY. WHEN USING YOUR OVEN, AVOID OPENING THE DOOR UNNECESSARILY, AS EACH OPENING RELEASES A SIGNIFICANT AMOUNT OF HEAT. FOR LAUNDRY, OPT FOR COLD WATER WASHES WHEN POSSIBLE AND USE THE HIGH SPIN SETTING TO REMOVE EXCESS WATER, REDUCING DRYING TIME.

#### REDUCING PHANTOM LOAD

MANY ELECTRONIC DEVICES, EVEN WHEN TURNED OFF, CONTINUE TO DRAW A SMALL AMOUNT OF ELECTRICITY, OFTEN REFERRED TO AS "PHANTOM LOAD" OR "VAMPIRE POWER." UNPLUGGING CHARGERS, TVS, COMPUTERS, AND OTHER ELECTRONICS WHEN THEY ARE NOT IN USE OR USING SMART POWER STRIPS THAT CUT POWER TO IDLE DEVICES CAN ELIMINATE THIS WASTED ENERGY.

### TAKING ADVANTAGE OF PGE PROGRAMS AND REBATES

THIS ALLOWS FOR PRECISE ADJUSTMENTS TO HEATING AND COOLING, ENSURING YOU ARE NOT WASTING ENERGY WHEN IT'S NOT NEEDED.

#### SMART LIGHTING SYSTEMS

SMART LIGHTING SYSTEMS ALLOW YOU TO CONTROL YOUR LIGHTS REMOTELY, SET SCHEDULES, AND EVEN ADJUST BRIGHTNESS LEVELS. PGE'S TOU PLANS TYPICALLY DEFINE SPECIFIC HOURS AS PEAK, MID-PEAK, AND OFF-PEAK. PEAK HOURS USUALLY OCCUR IN THE LATE AFTERNOON AND EARLY EVENING WHEN DEMAND FOR ELECTRICITY IS AT ITS HIGHEST. OFF-PEAK HOURS ARE TYPICALLY OVERNIGHT AND DURING THE MIDDAY. IT IS ESSENTIAL TO CONSULT YOUR SPECIFIC TOU RATE PLAN DETAILS TO UNDERSTAND THESE TIMEFRAMES ACCURATELY.

#### SHIFTING ENERGY CONSUMPTION

THE KEY TO SAVING MONEY ON TOU RATES IS TO SHIFT YOUR HIGH-ENERGY ACTIVITIES TO OFF-PEAK HOURS.
