## UNDERSTANDING YOUR TAX OBLIGATIONS AS A FREELANCER

AS A FREELANCE ONLINE TUTOR, YOU ARE CONSIDERED SELF-EMPLOYED. THIS MEANS YOU ARE RESPONSIBLE FOR CALCULATING AND PAYING YOUR OWN INCOME TAXES AND SELF-EMPLOYMENT TAXES (SOCIAL SECURITY AND MEDICARE). UNLIKE EMPLOYEES WHO HAVE TAXES WITHHELD FROM THEIR PAYCHECKS, YOU NEED TO PROACTIVELY MANAGE YOUR TAX LIABILITIES. THIS OFTEN INVOLVES MAKING ESTIMATED TAX PAYMENTS QUARTERLY TO AVOID PENALTIES. FAMILIARIZING YOURSELF WITH THE INTRICACIES OF SELF-EMPLOYMENT TAXES AND INCOME TAX BRACKETS IS THE FIRST STEP TOWARD EFFECTIVE TAX PLANNING.

THE U.S. TAX SYSTEM IS DESIGNED TO ALLOW BUSINESSES, INCLUDING FREELANCE OPERATIONS, TO DEDUCT ORDINARY AND NECESSARY EXPENSES INCURRED IN THE COURSE OF EARNING INCOME. FOR AN ONLINE TUTOR, THESE EXPENSES DIRECTLY RELATE TO PROVIDING YOUR SERVICES, SETTING UP YOUR WORKSPACE, AND INVESTING IN YOUR PROFESSIONAL GROWTH. BY METICULOUSLY TRACKING AND CLAIMING THESE DEDUCTIONS, YOU EFFECTIVELY LOWER YOUR TAXABLE PROFIT, WHICH IN TURN REDUCES THE AMOUNT OF TAX YOU OWE. IT'S NOT ABOUT FINDING LOOPHOLES; IT'S ABOUT ACCURATELY REFLECTING YOUR BUSINESS'S ACTUAL COST OF OPERATION.

## HOME OFFICE DEDUCTIONS FOR ONLINE TUTORS

ONE OF THE MOST SIGNIFICANT TAX DEDUCTIONS FOR FREELANCE ONLINE TUTORS IS THE HOME OFFICE DEDUCTION. TO QUALIFY, YOU MUST USE A SPECIFIC AREA OF YOUR HOME EXCLUSIVELY AND REGULARLY AS YOUR PRINCIPAL PLACE OF BUSINESS. THIS MEANS THE SPACE CANNOT BE USED FOR PERSONAL ACTIVITIES; IT MUST BE DEDICATED SOLELY TO YOUR TUTORING WORK. FOR EXAMPLE, A DESK IN YOUR LIVING ROOM THAT'S ALSO USED FOR FAMILY ACTIVITIES GENERALLY WON'T QUALIFY, BUT A SEPARATE ROOM OR A CLEARLY DEFINED AREA WITHIN A ROOM USED ONLY FOR ONLINE TUTORING SESSIONS AND PREPARATION WOULD.

THERE ARE TWO METHODS FOR CALCULATING THE HOME OFFICE DEDUCTION: THE SIMPLIFIED OPTION AND THE REGULAR METHOD. THE SIMPLIFIED OPTION ALLOWS YOU TO DEDUCT A STANDARD AMOUNT PER SQUARE FOOT OF YOUR HOME USED FOR BUSINESS, UP TO A MAXIMUM SQUARE FOOTAGE. THIS IS A STRAIGHTFORWARD APPROACH THAT REQUIRES LESS DETAILED RECORD-KEEPING. THE REGULAR METHOD, ON THE OTHER HAND, ALLOWS YOU TO DEDUCT A PORTION OF YOUR ACTUAL HOME EXPENSES, SUCH AS MORTGAGE INTEREST, RENT, UTILITIES, PROPERTY TAXES, HOMEOWNER'S INSURANCE, AND REPAIRS. THIS METHOD

GENERALLY REQUIRES MORE METICULOUS TRACKING OF EXPENSES AND SQUARE FOOTAGE.

## CALCULATING THE REGULAR HOME OFFICE DEDUCTION

TO USE THE REGULAR METHOD, YOU'LL NEED TO DETERMINE THE PERCENTAGE OF YOUR HOME USED FOR BUSINESS. THIS IS TYPICALLY CALCULATED BY DIVIDING THE SQUARE FOOTAGE OF YOUR DEDICATED OFFICE SPACE BY THE TOTAL SQUARE FOOTAGE OF YOUR HOME. FOR INSTANCE, IF YOUR OFFICE IS 150 SQUARE FEET AND YOUR HOME IS 1500 SQUARE FEET, YOU CAN DEDUCT 10% OF YOUR QUALIFYING HOME EXPENSES. THESE QUALIFYING EXPENSES CAN INCLUDE:

- MORTGAGE INTEREST
- RENT
- PROPERTY TAXES
- HOMEOWNER'S INSURANCE
- UTILITIES (ELECTRICITY, GAS, WATER)
- HOME REPAIRS AND MAINTENANCE
- DEDUCTIBLE CASUALTY LOSSES (E.G., FROM A NATURAL DISASTER)

IT'S CRUCIAL TO KEEP DETAILED RECORDS OF ALL THESE EXPENSES, INCLUDING RECEIPTS AND STATEMENTS. THE IRS MAY SCRUTINIZE HOME OFFICE DEDUCTIONS, SO HAVING ROBUST DOCUMENTATION IS ESSENTIAL FOR SUPPORTING YOUR CLAIM SHOULD YOUR RETURN BE AUDITED.

## THE SIMPLIFIED HOME OFFICE DEDUCTION

THE SIMPLIFIED OPTION OFFERS A MUCH EASIER WAY TO CLAIM YOUR HOME OFFICE DEDUCTION. YOU CAN DEDUCT \$5 PER SQUARE FOOT OF YOUR HOME USED FOR BUSINESS, WITH A MAXIMUM OF 300 SQUARE FEET. THIS MEANS THE MAXIMUM DEDUCTION UNDER THIS METHOD IS \$1,500 PER YEAR. WHILE THIS MAY RESULT IN A SMALLER DEDUCTION THAN THE REGULAR METHOD FOR SOME, IT SIGNIFICANTLY REDUCES THE ADMINISTRATIVE BURDEN OF TRACKING NUMEROUS HOUSEHOLD EXPENSES. YOU DON'T NEED TO KEEP RECEIPTS FOR UTILITIES OR REPAIRS IF YOU CHOOSE THIS METHOD.

## EXPENSES RELATED TO EDUCATIONAL MATERIALS AND RESOURCES

INVESTING IN QUALITY EDUCATIONAL MATERIALS IS FUNDAMENTAL TO PROVIDING EXCELLENT ONLINE TUTORING SERVICES. MANY OF THESE PURCHASES CAN BE DEDUCTED AS BUSINESS EXPENSES. THIS INCLUDES TEXTBOOKS, WORKBOOKS, ONLINE LEARNING PLATFORMS, SUBSCRIPTION SERVICES FOR EDUCATIONAL CONTENT, AND EVEN SOFTWARE SPECIFICALLY DESIGNED FOR TEACHING OR TUTORING. IF YOU PURCHASE A NEW SET OF CURRICULUM GUIDES OR SPECIALIZED SOFTWARE TO BETTER TEACH A PARTICULAR SUBJECT, THESE ARE LEGITIMATE BUSINESS EXPENSES.

THINK BROADLY ABOUT WHAT YOU NEED TO EFFECTIVELY DELIVER YOUR TUTORING SERVICES. THIS COULD EXTEND TO PHYSICAL MANIPULATIVES FOR YOUNGER STUDENTS, FLASHCARDS, EDUCATIONAL GAMES, OR EVEN SUBSCRIPTIONS TO ACADEMIC JOURNALS OR PROFESSIONAL TEACHING PUBLICATIONS THAT ENHANCE YOUR KNOWLEDGE AND ABILITY TO TEACH. THE KEY IS THAT THESE MATERIALS ARE DIRECTLY RELATED TO YOUR WORK AS AN ONLINE TUTOR AND ARE USED TO FACILITATE YOUR STUDENTS' LEARNING. KEEP RECEIPTS FOR ALL THESE PURCHASES.

## TECHNOLOGY AND INTERNET COSTS

IN THE REALM OF ONLINE TUTORING, TECHNOLOGY IS YOUR LIFELINE. THEREFORE, EXPENSES RELATED TO YOUR COMPUTER, INTERNET, AND OTHER ESSENTIAL TECH ARE GENERALLY DEDUCTIBLE. THIS INCLUDES THE COST OF YOUR COMPUTER OR LAPTOP, MONITOR, KEYBOARD, MOUSE, WEBCAM, AND MICROPHONE IF THEY ARE USED FOR YOUR BUSINESS. IF YOU PURCHASE A NEW

COMPUTER SOLELY FOR YOUR TUTORING BUSINESS, YOU CAN TYPICALLY DEDUCT ITS FULL COST IN THE YEAR OF PURCHASE, OR DEPRECIATE IT OVER SEVERAL YEARS.

SIMILARLY, A PORTION OF YOUR INTERNET SERVICE BILL CAN BE DEDUCTED. IF YOU USE YOUR INTERNET CONNECTION FOR BOTH BUSINESS AND PERSONAL USE, YOU'LL NEED TO DETERMINE THE BUSINESS-USE PERCENTAGE. THIS CAN BE BASED ON USAGE LOGS OR A REASONABLE ESTIMATE OF HOW MUCH TIME YOU SPEND ONLINE FOR TUTORING VERSUS PERSONAL BROWSING. OTHER DEDUCTIBLE TECHNOLOGY EXPENSES MIGHT INCLUDE SOFTWARE LICENSES FOR VIDEO CONFERENCING PLATFORMS (LIKE ZOOM OR SKYPE), CLOUD STORAGE SERVICES, OR SPECIALIZED EDUCATIONAL SOFTWARE THAT YOU USE TO CREATE LESSONS OR INTERACT WITH STUDENTS.

## COMPUTER AND SOFTWARE DEDUCTIONS

WHEN YOU PURCHASE A COMPUTER OR OTHER SIGNIFICANT TECHNOLOGY HARDWARE FOR YOUR BUSINESS, YOU USUALLY HAVE TWO OPTIONS FOR DEDUCTING THE COST: SECTION 179 DEDUCTION OR BONUS DEPRECIATION. SECTION 179 ALLOWS YOU TO DEDUCT THE FULL PURCHASE PRICE OF QUALIFYING BUSINESS ASSETS IN THE YEAR THEY ARE PLACED IN SERVICE, UP TO A CERTAIN LIMIT. BONUS DEPRECIATION ALLOWS FOR A SIMILAR UPFRONT DEDUCTION, OFTEN FOR A HIGHER PERCENTAGE OF THE COST IN THE FIRST YEAR, DEPENDING ON CURRENT TAX LAW. IF YOU DON'T USE THESE ACCELERATED DEPRECIATION METHODS, YOU CAN ALSO DEPRECIATE THE ASSET OVER ITS USEFUL LIFE.

## INTERNET AND COMMUNICATION EXPENSES

THE PORTION OF YOUR MONTHLY INTERNET BILL ATTRIBUTABLE TO YOUR BUSINESS CAN BE CLAIMED. FOR EXAMPLE, IF YOU SPEND 50% OF YOUR ONLINE TIME CONDUCTING TUTORING SESSIONS OR PREPARING LESSONS, YOU CAN DEDUCT 50% OF YOUR INTERNET BILL. THIS ALSO APPLIES TO YOUR CELL PHONE IF IT'S USED FOR BUSINESS CALLS OR COMMUNICATION RELATED TO YOUR TUTORING WORK. KEEP RECORDS OF YOUR BILLS AND CALCULATE THE BUSINESS-USE PERCENTAGE CAREFULLY. THIS INCLUDES PHONE BILLS IF YOU HAVE A DEDICATED BUSINESS LINE OR A SIGNIFICANT PORTION OF YOUR PERSONAL PHONE USAGE FOR CLIENT COMMUNICATION.

## PROFESSIONAL DEVELOPMENT AND BUSINESS EXPENSES

INVESTING IN YOUR PROFESSIONAL GROWTH AS A TUTOR CAN LEAD TO MORE EFFECTIVE TEACHING AND, CONSEQUENTLY, GREATER INCOME. EXPENSES RELATED TO PROFESSIONAL DEVELOPMENT ARE OFTEN DEDUCTIBLE. THIS INCLUDES ATTENDING WORKSHOPS, SEMINARS, CONFERENCES, OR ONLINE COURSES THAT ENHANCE YOUR TEACHING SKILLS OR SUBJECT MATTER EXPERTISE. MEMBERSHIP FEES FOR PROFESSIONAL ORGANIZATIONS RELATED TO TUTORING OR EDUCATION CAN ALSO BE DEDUCTED.

OTHER BUSINESS EXPENSES THAT CAN BE DEDUCTED INCLUDE THE COST OF BUSINESS CARDS, MARKETING MATERIALS, WEBSITE HOSTING FEES, AND ANY FEES PAID FOR ONLINE TUTORING PLATFORMS. EVEN THE COST OF PROFESSIONAL LIABILITY INSURANCE, IF YOU CHOOSE TO OBTAIN IT, IS A DEDUCTIBLE BUSINESS EXPENSE. THESE ARE ALL COSTS OF DOING BUSINESS THAT HELP YOU MAINTAIN AND GROW YOUR FREELANCE TUTORING PRACTICE.

## TRAINING AND EDUCATION FOR TUTORS

ATTENDING TRAINING SESSIONS, WEBINARS, OR OBTAINING CERTIFICATIONS THAT DIRECTLY RELATE TO YOUR TUTORING SUBJECTS OR PEDAGOGICAL METHODS ARE DEDUCTIBLE. FOR INSTANCE, IF YOU TUTOR MATH AND ATTEND A WORKSHOP ON NEW TEACHING STRATEGIES FOR ALGEBRA, THAT COST IS A BUSINESS EXPENSE. LIKewise, IF YOU ARE LOOKING TO EXPAND YOUR SERVICES, TAKING A COURSE IN A NEW SUBJECT AREA THAT YOU INTEND TO TUTOR IN CAN ALSO BE DEDUCTIBLE. THE IRS REQUIRES THAT SUCH EDUCATION MAINTAINS OR IMPROVES SKILLS REQUIRED IN YOUR PRESENT BUSINESS, OR MEETS REQUIREMENTS IMPOSED BY LAW OR BY YOUR EMPLOYER (WHICH, IN THE CASE OF A FREELANCER, IS ESSENTIALLY YOUR CLIENTS' NEEDS AND EXPECTATIONS).

## MARKETING AND ADVERTISING COSTS

TO ATTRACT STUDENTS, YOU NEED TO MARKET YOUR SERVICES. ANY MONEY SPENT ON ADVERTISING YOUR FREELANCE TUTORING BUSINESS IS DEDUCTIBLE. THIS CAN INCLUDE ONLINE ADS (GOOGLE ADS, SOCIAL MEDIA ADS), PRINTING FLYERS, CREATING A PROFESSIONAL WEBSITE, OR PAYING FOR LISTINGS ON FREELANCE PLATFORMS. EVEN THE COST OF A PROFESSIONAL

LOGO DESIGN OR THE DEVELOPMENT OF MARKETING COLLATERAL FALLS UNDER THIS CATEGORY. KEEPING TRACK OF ALL YOUR MARKETING EXPENDITURES IS CRUCIAL FOR CLAIMING THESE DEDUCTIONS.

## TRANSPORTATION AND TRAVEL DEDUCTIONS

WHILE MOST ONLINE TUTORS WORK FROM HOME, THERE MAY BE INSTANCES WHERE TRAVEL IS REQUIRED FOR YOUR BUSINESS. IF YOU TRAVEL TO A STUDENT'S HOME, ATTEND AN IN-PERSON PROFESSIONAL DEVELOPMENT EVENT, OR MEET WITH CLIENTS, THESE TRANSPORTATION COSTS CAN BE DEDUCTIBLE. YOU CAN DEDUCT MILEAGE DRIVEN FOR BUSINESS PURPOSES USING THE STANDARD MILEAGE RATE, OR YOU CAN DEDUCT THE ACTUAL COSTS OF OPERATING YOUR VEHICLE (GAS, OIL, REPAIRS, INSURANCE, DEPRECIATION). YOU'LL NEED TO KEEP A LOG OF YOUR BUSINESS MILEAGE, NOTING THE DATE, DESTINATION, AND PURPOSE OF EACH TRIP.

IF YOUR TRAVEL REQUIRES AN OVERNIGHT STAY, YOU MAY ALSO BE ABLE TO DEDUCT THE COST OF MEALS AND LODGING. FOR MEALS, THE IRS GENERALLY ALLOWS A DEDUCTION OF 50% OF THE COST. IT'S IMPORTANT TO DIFFERENTIATE BETWEEN COMMUTING TO A REGULAR PLACE OF WORK (WHICH IS GENERALLY NOT DEDUCTIBLE) AND BUSINESS-RELATED TRAVEL. FOR A FREELANCE ONLINE TUTOR, TRAVEL TO A STUDENT'S HOME FOR A SCHEDULED SESSION WOULD BE CONSIDERED BUSINESS TRAVEL.

## OTHER POTENTIAL TAX DEDUCTIONS FOR ONLINE TUTORS

BEYOND THE MAJOR CATEGORIES, THERE ARE SEVERAL OTHER EXPENSES THAT FREELANCE ONLINE TUTORS CAN OFTEN DEDUCT. THESE CAN INCLUDE BANK FEES ASSOCIATED WITH YOUR BUSINESS ACCOUNT, PROFESSIONAL LIABILITY INSURANCE PREMIUMS, LEGAL AND ACCOUNTING FEES INCURRED FOR YOUR BUSINESS, AND EVEN A PORTION OF THE COST OF ANY BUSINESS SOFTWARE YOU SUBSCRIBE TO. IF YOU RECEIVE PAYMENTS VIA PLATFORMS THAT CHARGE TRANSACTION FEES, THESE FEES ARE ALSO TYPICALLY DEDUCTIBLE AS A COST OF DOING BUSINESS.

CONSIDER ANY EXPENSE THAT IS ORDINARY AND NECESSARY FOR YOUR TUTORING BUSINESS. THIS MIGHT INCLUDE SUBSCRIPTIONS TO EDUCATIONAL SOFTWARE, PROFESSIONAL LIABILITY INSURANCE, OR EVEN SMALL OFFICE SUPPLIES LIKE PENS, PAPER, AND PRINTER INK. WHILE THESE MAY SEEM MINOR INDIVIDUALLY, THEY CAN ADD UP OVER THE TAX YEAR, CONTRIBUTING TO A MORE SIGNIFICANT REDUCTION IN YOUR OVERALL TAX LIABILITY. DON'T OVERLOOK THESE SMALLER, BUT STILL VALUABLE, DEDUCTIONS.

## RECORD-KEEPING BEST PRACTICES FOR FREELANCERS

METICULOUS RECORD-KEEPING IS THE CORNERSTONE OF CLAIMING ANY TAX DEDUCTION. WITHOUT PROPER DOCUMENTATION, YOUR CLAIMS CAN BE DISALLOWED BY THE IRS. IT'S ADVISABLE TO SET UP A DEDICATED SYSTEM FOR TRACKING ALL YOUR BUSINESS INCOME AND EXPENSES FROM THE OUTSET. THIS COULD INVOLVE USING ACCOUNTING SOFTWARE, A SPREADSHEET, OR EVEN A DEDICATED NOTEBOOK, AS LONG AS IT'S ORGANIZED AND COMPREHENSIVE.

KEY RECORDS TO MAINTAIN INCLUDE INVOICES ISSUED TO CLIENTS, RECEIPTS FOR ALL BUSINESS PURCHASES (CATEGORIZED BY EXPENSE TYPE), BANK STATEMENTS FOR YOUR BUSINESS ACCOUNT, LOGS OF BUSINESS MILEAGE, AND RECORDS OF ANY ESTIMATED TAX PAYMENTS MADE. FOR THE HOME OFFICE DEDUCTION, KEEP FLOOR PLANS OR MEASUREMENTS OF YOUR HOME AND OFFICE SPACE. HOLDING ONTO THESE RECORDS FOR AT LEAST THREE YEARS (THE TYPICAL STATUTE OF LIMITATIONS FOR TAX AUDITS) IS RECOMMENDED.

## USING ACCOUNTING SOFTWARE

ACCOUNTING SOFTWARE CAN BE AN INVALUABLE TOOL FOR FREELANCE ONLINE TUTORS. PROGRAMS LIKE QUICKBOOKS, XERO, OR FRESHBOOKS ARE DESIGNED TO TRACK INCOME AND EXPENSES, CATEGORIZE TRANSACTIONS, GENERATE FINANCIAL REPORTS, AND OFTEN HELP WITH INVOICING AND TAX PREPARATION. MANY OF THESE PLATFORMS OFFER MOBILE APPS, ALLOWING YOU TO EASILY RECORD EXPENSES ON THE GO AND UPLOAD RECEIPT IMAGES. THIS CAN SIGNIFICANTLY STREAMLINE YOUR RECORD-KEEPING PROCESS AND REDUCE THE LIKELIHOOD OF ERRORS OR MISSED DEDUCTIONS.

## ORGANIZING RECEIPTS AND INVOICES

DEVELOP A SYSTEM FOR ORGANIZING YOUR RECEIPTS AND INVOICES THAT WORKS FOR YOU. THIS COULD INVOLVE USING PHYSICAL FOLDERS, BINDERS, OR DIGITAL SOLUTIONS. FOR PHYSICAL RECEIPTS, A SIMPLE ACCORDION FILE OR A BINDER WITH CLEAR SLEEVES CAN KEEP THINGS TIDY. DIGITALLY, YOU CAN SCAN OR TAKE PHOTOS OF RECEIPTS AND SAVE THEM IN ORGANIZED FOLDERS ON YOUR COMPUTER OR CLOUD STORAGE. ENSURE EACH RECEIPT IS CLEARLY LABELED WITH THE DATE, VENDOR, AMOUNT, AND THE TYPE OF EXPENSE. SIMILARLY, KEEP METICULOUS RECORDS OF ALL INCOME RECEIVED, INCLUDING PAYMENT DATES AND AMOUNTS.

### Q: CAN I DEDUCT MY INTERNET BILL AS A FREELANCE ONLINE TUTOR?

A: YES, YOU CAN DEDUCT THE BUSINESS-USE PORTION OF YOUR INTERNET BILL. IF YOU USE YOUR INTERNET FOR BOTH PERSONAL AND BUSINESS PURPOSES, YOU'LL NEED TO CALCULATE THE PERCENTAGE OF YOUR ONLINE TIME THAT IS DEDICATED TO TUTORING AND DEDUCT THAT PORTION OF THE MONTHLY BILL.

### Q: ARE THE COSTS OF EDUCATIONAL MATERIALS TAX-DEDUCTIBLE FOR ONLINE TUTORS?

A: ABSOLUTELY. EXPENSES FOR TEXTBOOKS, WORKBOOKS, ONLINE LEARNING PLATFORMS, EDUCATIONAL SOFTWARE, SUBSCRIPTIONS TO ACADEMIC JOURNALS, AND OTHER TEACHING AIDS THAT ARE DIRECTLY RELATED TO YOUR TUTORING SERVICES ARE TYPICALLY DEDUCTIBLE.

### Q: WHAT IF I WORK FROM A CO-WORKING SPACE INSTEAD OF MY HOME?

A: WHILE NOT ALWAYS STRICTLY REQUIRED TO CLAIM DEDUCTIONS, IT IS HIGHLY RECOMMENDED. REGISTERING YOUR BUSINESS, OBTAINING AN EMPLOYER IDENTIFICATION NUMBER (EIN) IF APPLICABLE, AND OPERATING AS A FORMAL BUSINESS ENTITY CAN PROVIDE LEGAL AND TAX BENEFITS AND DEMONSTRATES A SERIOUS APPROACH TO YOUR BUSINESS.

### Q: HOW DO I TRACK MILEAGE FOR BUSINESS TRAVEL AS AN ONLINE TUTOR?

A: YOU SHOULD MAINTAIN A DETAILED LOG OF ALL BUSINESS MILEAGE. THIS LOG SHOULD INCLUDE THE DATE OF TRAVEL, THE STARTING POINT AND DESTINATION, THE BUSINESS PURPOSE OF THE TRIP (E.G., TRAVELING TO A STUDENT'S HOME), AND THE NUMBER OF MILES DRIVEN. YOU CAN THEN USE EITHER THE STANDARD MILEAGE RATE OR DEDUCT ACTUAL VEHICLE EXPENSES.

### Q: CAN I DEDUCT THE COST OF PROFESSIONAL DEVELOPMENT COURSES AND

## CERTIFICATIONS?

A: YES, IF THE PROFESSIONAL DEVELOPMENT COURSES, WORKSHOPS, SEMINARS, OR CERTIFICATIONS MAINTAIN OR IMPROVE THE SKILLS NEEDED FOR YOUR CURRENT TUTORING BUSINESS, THEIR COSTS ARE GENERALLY DEDUCTIBLE.

## Q: WHAT IS THE DIFFERENCE BETWEEN THE SIMPLIFIED AND REGULAR HOME OFFICE DEDUCTION METHODS?
