SOME ADVANCED JOURNAL APPS MIGHT INTEGRATE WITH OTHER PRODUCTIVITY TOOLS. EXPLORE THESE INTEGRATIONS, AS THEY CAN STREAMLINE YOUR WORKFLOW, FOR INSTANCE, BY AUTOMATICALLY BACKING UP EXPORTED PDFs TO CLOUD STORAGE OR ALLOWING YOU TO IMPORT INFORMATION FROM OTHER SOURCES.

## USE PDF EXPORTS FOR SPECIFIC GOALS

THINK ABOUT HOW YOU CAN ACTIVELY USE YOUR EXPORTED PDFs. CREATE A WEEKLY REVIEW DOCUMENT, COMPILE MONTHLY PROJECT SUMMARIES, OR BUILD A PORTFOLIO OF YOUR CREATIVE WRITING. HAVING A SPECIFIC GOAL FOR YOUR EXPORTS WILL GIVE YOUR JOURNALING PRACTICE MORE PURPOSE AND DRIVE.
